CITY OF FORT ST. JOHN

Municipal Ticket Information Bylaw No. 2429, 2018

A Bylaw of the Corporation of the City of Fort St. John (hereinafter called "The City") to regulate the Municipal Ticket Information system in the City.

WHEREAS Section 264 (1)(a) of the *Community Charter* empowers the Council of the City, by bylaw, to designate those bylaws for which municipal ticket information may be used as a means of bylaw enforcement;

AND WHEREAS Section 264 (1)(c) of the *Community Charter* empowers the Council to, by bylaw, authorize the use of any word or expression on a municipal ticket information to designate an offence against a bylaw;

AND WHEREAS the Council deems it expedient to authorize the use of municipal ticket information for the enforcement of certain bylaws, to authorize the use of certain words or expressions to designate certain bylaw offences and to set certain fine amounts.

NOW THEREFORE, the Council of the City of Fort St. John in open meeting assembled enacts as follows:

SECTION 1 – TITLE

Citation

1.1 This Bylaw may be cited as "Municipal Ticket Information System Bylaw No. 2429, 2018."

Repeal

1.2 Municipal Ticket Information System Bylaw No. 1321, 1998 is hereby repealed.

SECTION 2 – DEFINITIONS

2.1 In this Bylaw the following terms have the following meanings:

"Bylaw Enforcement Officer" means a person or persons appointed from time to time by resolution of City Council pursuant to Section 36 of the *Police Act* to enforce regulatory bylaws of the municipality;

"City" means The Corporation of the City of Fort St. John;

SECTION 2 – DEFINITIONS (continued)

2.1 In this Bylaw the following terms have the following meanings:

"Designated Bylaw" means a bylaw listed in Column 1 of Schedule "A" to this Bylaw;

"Designated Schedule" means the schedule specified in Column 3 of Schedule "A" to this Bylaw that corresponds with and is attached to the Designated Bylaw being enforced.

<u>SECTION 3 – GENERAL PROVISIONS</u>

- 3.1 The bylaws listed in Column 1 of Schedule "A" to this Bylaw are designated as bylaws that may be enforced by means of a ticket issued under section 264 of the *Community Charter*.
- 3.2 The persons who act in the job positions or titles listed in Column 2 of Schedule "A" to this Bylaw are designated Bylaw Enforcement Officers for the purpose of enforcing the bylaws listed in Column 1 of Schedule "A" opposite the respective job positon.
- 3.3 For the purposes of a ticket issued to enforce a section of a Designated Bylaw:
 - (a) the words and expressions that may be used on the ticket to designate the offence; and
 - (b) the fine amount or amounts applicable to that offence;

are as specified in the Designated Schedule of the bylaw being enforced.

SECTION 4 – ADMINISTRATIVE

- 4.1 Schedule "A" is attached to this bylaw and forms a part of this Bylaw.
- 4.2 If any provision of this Bylaw is declared or held to be illegal, invalid or ultra vires, in whole or in part, then the provision shall not apply and the remainder of this Bylaw shall continue in full force and effect and be construed as if it had been enacted without the illegal, invalid, or ultra vires provision.
