A Bylaw to determine the areas of the City of Fort St. John exempt from taxation as provided under the *Community Charter*

WHEREAS, Council deems it expedient to exempt certain lands, improvements, or both, in the City of Fort St. John from taxation; and

WHEREAS, Council is authorized to grant such exemptions under the provisions of Section 224 of the *Community Charter*:

NOW THEREFORE, Council of the City of Fort St. John in open meeting assembled, enacts as follows:

1. <u>TITLE</u>

This Bylaw may be cited as "City of Fort St. John (Fort St. John Curling Club Management Agreement) Permissive Tax Exemption Bylaw No. 2525, 2020".

2. <u>COMMUNITY CHARTER SECTION 224 – PERMISSIVE EXEMPTIONS</u>

The following lands and improvements are exempt from taxation for the calendar years 2021, 2022, 2023, 2024 and 2025:

City of Fort St. John (Fort St. John Curling Club Lease)

Roll No. 8650.000, described as Lot 1, Plan 25780, as shown on Schedule A attached hereto and forming part of this Bylaw. Registered owner City of Fort St. John and as per the management and lease agreement to the Fort St. John Curling Club.

3. <u>REPEAL</u>

City of Fort St. John (Fort St. John Curling Club Management Agreement) Permissive Tax Exemption Bylaw No. 2447, 2018 is hereby repealed.
